Thank you for your interest in a sidewalk sale outside your business. Enclosed are the Sidewalk Sale Application and Agreement needed to secure your permit to occupy a portion of the City's public right-of-way.

PROCESS

Once your application is received, it will be reviewed by City personnel and presented at a City of South Bend Board of Public Works meeting for approval. Once approved, a signed copy of your permit and agreement will be emailed or mailed to you. Note: A permit for a sidewalk sale is valid subject to proper ADA clearance from obstructions.

- ✓ Complete business address and description of location of the sidewalk sale.
