The City's Utility Assistance Program is available to help you or a loved one with monthly water and sewer bills for qualifying applicants. Those who qualify could see a reduction in their bill up to \$25.50 every month for a year. To apply or learn more, visit www.southbendin.gov/uap.

The City's fall leaf pickup program is expected to begin on October 31 and will run through December 5th. As a reminder, residents should rake leaves into their tree lawn by 6 a.m., and make sure their leaf pile doesn't have sticks, trash or debris or blocks access to vehicles.

Clerk's Corner

Most of us understand why it's illegal to burn waste, but we ignore the regulation when we light bonfires. These fires produce carbon, hydrogen, arsenic, selenium, zinc, and lead particles. We call these bits "ash," and it can harm our community.

Sec. 9-19. Intent and purposes of article.

The Common Council believes that reasonable regulations should be enacted to minimize air pollution caused by burning within our City.

Sec. 9-20. Types of burning prohibited.

- (a) No person shall start, kindle, cause, allow or maintain any form of leaf burning or rubbish or trash burning on private or public property, except as specifically authorized by this Code.
- (b) No person shall burn or cause to be burned, any leaves, grass, tree limbs, branches, paper, rubbish or trash, upon any street, alley or sidewalk within the City.

Here are some safety tips around bon fires:

- Don't build a bonfire when it's windy.
- Keep water handy in case the fire spreads.
- Watch the bonfire and adjacent kids.
- Don't burn aerosols, canisters, or foam/paint.
 Chemicals with flammable components can spread flames or emit poisonous gases. These containers could explode, inflicting damage.
- Burn dry, seasoned, or smokeless wood.
- After the bonfire, turn over the burned materials and water the area.
