Program Overview

Energy use in buildings represented nearly two-thirds of South Bend's greenhouse gas (GHG) emissions in 2019.

Our City's Climate Action Plan calls for expanding energy audits for buildings and increasing local incentives for energy efficiency. The City's Office of Sustainability, the mission-driven lender IFF, and CDFI Friendly South Bend launched the Energy Assistance and Solar Savings Initiative (EASSI) in 2022 in response to this call.

EASSI has historically helped nonprofits access solar energy and improve their energy efficiency through subsidized energy assessments, City-sponsored grants, and low-interest loans from IFF. For 2024, we are opening the program to local businesses to receive an energy assessment and grant funding. For-profit entities will not be able to

receive lending from IFF but can use traditional lending sources if needed in addition to the grant. CDFI Friendly South Bend, can assist participants in exploring financial options.

New EASSI Applicants

How it works for new applicants:

1. Your organization completes this application form. If you are a business you have two options. Apply for a solar matching grant, which will require submitting a quote(s). OR join the traditional EASSI program, which provides an on-site energy assessment and is described below.
2. If approved for the program, your organization will receive an energy assessment (conducted by IFF and fully subsidized by the City).
3. The City and IFF will review the assessment with you and support you in choosing efficiency projects to pursue.
4. Once you select the projects, you will submit a grant application. Non-profit organizations may also apply for lending through IFF if additional resources are needed. CDFI Friendly South Bend can also provide support in addressing finance gaps.

Possible improvements supported through EASSI include:

- Solar panel installation
- Geothermal installation
- HVAC replacement
- ENERGY STAR® appliance upgrades (refrigerators, washers, dryers, etc.)
- Lighting upgrades
- Water heater upgrade
- Air/duct sealing
- Insulation/weatherization
- Window replacement

The following 5 core criteria are used to evaluate and select organizations for EASSI:

- Alignment with the program's mission
- Demonstrated need and project readiness

- Diversity in the type of organization and its services
- Diversity in its geographic location and the residents it serves
- Location in an underserved/underinvested/high vulnerability area

Returning EASSI Applicants

The program will also accept applications from organizations that received an EASSI grant in the first and second year of the program. Returning organizations should propose an eligible project (or multiple projects) and submit quotes through this application form. Returning organizations will not receive another energy assessment.

The following 5 core criteria are used to evaluate and select returning organizations for EASSI:

- Project readiness
- Alignment with EASSI's mission
- Potential to reduce energy consumption and emissions
- First come first serve basis
- Available funding

Funds are limited for returning organizations. This is a competitive grant opportunity. The more information you provide, the better position you are in to receive the EASSI grant.

Applications will be accepted until February 26th, 2024. We encourage those who are interested in the program to submit an application as soon as possible.
