
FENCE PERMIT CHECKLIST

- 1. Completed Application
- 2. Site Plan or Aerial View of property showing:
 - □ a. Property lines/size of property
 - □ b. Streets/alleys abutting property
 - \Box c. Size and location of driveway and any abutting driveways
 - \Box d. Size and location of all structures on property
 - e. Location of all easements on property (utility, drainage, etc.)
 - f. Size, type, and location of fence being planned
 - g. See an example of Site Plan here: <u>https://southbendin.gov/wp-</u> <u>content/uploads/2018/08/Example-of-Site-Plan.pdf</u>
 - 3. Special use/exception and/or variance approvals if applicable
 - 4. Signed contract showing estimated cost of construction
 - 5. All applicable contractors involved in the project (on application form)
 - 6. Permit fee: \$50
