Financial Empowerment Center Overview



Financial Empowerment Center (FEC)

- No-cost 1-1 financial counseling for all South Bend residents
- Program developed through Bloomberg / Cities for Financial Empowerment Fund
- Partnership with nonprofit to run day-to-day operations
- Located in new MLK Dream Center
- Program model includes counseling on banking, credit, debt, and savings





Tenets of FEC Model

- 1. Provide professional, one-on-one financial counseling as a free public service.
- 2. Systematically track data and outcomes for client management and evaluation.
- 3. Connect to a range of local government and nonprofit service delivery systems.
- 4. Prioritize sustainability efforts to become a permanent service in the locality




Success of FECs Nationally



Responsibilities of the Financial Counseling Provider

- Manage day-to-day operations of the FEC
- Recruit, hire and supervise FEC Staff (1 Program Manager, 2 Financial Counselors)
- Collect data using the FEC database (No cost to nonprofit)
- Support continued education and training of FEC staff
- Lead marketing and outreach efforts for FEC promotion, including participating in outreach events and presentations
- Adhere to City reporting requirements
- Coordinate with City personnel to develop and maintain social service partnerships
- Coordinate routinely with the City's local government manager about FEC operations



Responsibilities of the City

- Manage overall operations of FEC, including program oversight, design, and implementation
- Conduct formal reviews of financial counseling provider
- Support fundraising efforts to ensure FEC program sustainability
- Coordinate with nonprofit provider on social service partnerships
- Coordinate with nonprofit provider for FEC marketing and outreach
- Host the South Bend FEC website

RFP Overview

- Selected organization will serve as the financial counseling provider of the Financial Empowerment Center (FEC)
 - Qualified 501(c)(3) nonprofit organization
 - Implement high-volume, quality, one-on-one financial counseling services to low-income families
- \$500,000 contract for 2 years of operations
- Enter into partnership with the City to implement FEC programming and services

Experience in Community Involvement/Engagement	15 Points
Financial Capacity	15 Points
Unique Features of Applicant Organization	5 Points



Submitting Applications

Ideal Applicants will demonstrate:

- ☐ A thorough proposed approach to successfully operate the FEC
- ☐ Organizational and financial capacity to run the FEC
- ☐ Willingness to partner with the City
- ☐ Thorough understanding of program responsibilities and parameters
- ☐ Significant expertise in financial empowerment work
 - Financial counseling, coaching, assistance, programming, etc.
- ☐ Experience working with financially vulnerable residents
- ☐ Excellent strategies and dedication to community engagement and outreach
