Dear Business Owner/Resident:

Thank you for your interest in a sidewalk sale outside your business. Enclosed are the Sidewalk Sale Application and Agreement needed to secure your permit to occupy a portion of the City's public right-of-way.

### **PROCESS**

Once your application is received, it will be reviewed by City personnel and presented at a City of South Bend Board of Public Works meeting for approval. Once approved, a signed copy of your permit and agreement will be emailed or mailed to you. Note: A permit for a sidewalk sale is valid subject to proper ADA clearance from obstructions.

### **APPLICATION CHECKLIST**

Below is a checklist of items that need to be included with your submittal:

- ✓ Completed and signed Sidewalk Sale Permit Application
- ✓ Complete business address and description of location of the sidewalk sale.
- ✓ \$10 application fee. Make checks payable to City of South Bend. Cash and credit card payments can also be made when dropping off the application.

Permittee must allow for at least five (5) feet of unobstructed sidewalk for the free flow of pedestrian traffic at all times during the sale.]

## 1. AFFIRMATION

I, the undersigned, agree that I will abide by all of the provisions of Section 18-15 of the South Bend Municipal Code and with all the provisions stated above as conditions of the issuance of this Permit. I further agree to indemnify, defend and hold harmless the City of South Bend from any liability, loss, cost, damage or expenses, including attorney fees, which the City may suffer or incur as the result of any use of the public sidewalks for a sidewalk sale as permitted herein. I do hereby certify and affirm that all the information given in this application is true to the best of my knowledge.
